# 6.04.010 Keeping of swine and goats prohibited.

It is unlawful to keep swine or goats within the corporate limits of the town. (Ord. dated 12/5/95 § 1)

# 6.04.020 Farm animals and livestock prohibited—Exceptions.

- A. Except as provided in this chapter, it is unlawful to keep any horse, cow, fowl or other farm animal or livestock within the corporate limits of the town; provided, that any person or public educational facility who desires to keep an animal for his own family's use or for the public educational facility's educational purposes (i.e., raising livestock, chiefly for profit does not qualify for family use or educational purposes) may make application to the town council for permission to keep the animal or animals within the corporate limits.
- B. Upon receiving such application the town council shall consider whether the following conditions have been met:
  - 1. Applicant can show a legitimate family need or public educational purpose;
  - 2. The lot size is adequate to properly maintain the animal;
  - 3. The housing and facilities are adequate to properly maintain the animal;
- 4. There are no sanitation, odor, noise, aesthetic, or other potential health, welfare and/or nuisance problems associated with the keeping of the animal; and
- 5. Applicants will keep the animal only on premises they own, unless they have the landowner's permission.
- C. Upon a proper showing that the above conditions have been met, the town council shall issue a permit to keep the animal within the corporate limits of the town.
- D. Residents of the town may make a complaint to the town council that one or more of the above conditions has been violated. Upon receipt of such complaint the town council shall investigate such complaint. If the complaint has merit, the town council shall notify the permit holder of the complaint and shall inform the permit holder that he/she has two weeks to correct the violation. ### GENERAL PENALTY

## 1.08.010 Violation—Penalty.

A. Any person violating any of the provisions or failing to comply with any mandatory requirements of the ordinances of the town shall be guilty of an infraction unless the violation is made a misdemeanor by ordinance.

B. Except in cases where a different punishment is prescribed by any ordinance of the town, any person convicted of a misdemeanor for violation of an ordinance of the town is punishable by a fine and not more than five thousand dollars (\$5,000.00), or by imprisonment not to exceed one year or by both such fine and imprisonment.

C. Any person convicted of an infraction for violation of an ordinance of the town is punishable by a penalty of not more than five thousand dollars (\$5,000.00).

D. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the ordinances of the town is committed, continued or permitted by any such person, and he shall be punishable accordingly. (Ord. 333 § 1, 1995)
